6. Director's Report by John Gawarecki

Staff update:

- New Spanish teacher will start on Monday.
- John Sundeen (sp?), EA, who had been hired this summer will not be working at MSA. The job has been posted and hopefully will be filled by the end of the week.

Building update:

- Special Education room's wall was removed and will get new carpet for the full room.
- Former Senior Lounge became the new Room 17. It will house Spanish and Math.
- Teacher's lounge in Building B is moved to the basement. The remodeled former teacher's lounge is now the new office for the Assistant Director.
- Shannon Froberg will go to the 2nd floor.
- There is a new conference work area for teachers.

Security:

 All exterior doors in public spaces are now equipped with an alarm system. All teachers will have key to override.

Early drop-off and fee change:

- The rate for this year will be \$10/day or \$150/semester for high schoolers.
- There is Y Care for middle school for a charge.

Exchange students:

- Charter schools typically will allow exchange students to attend if a host student attends that charter school. Currently, MSA does not have any previous policy on this.
- There are 2 exchange students (from France and Germany) who would like to attend MSA whose host families do not have MSA students (with middle schoolers and younger children). Both exchange students are in 11th grade and are from the same host/exchange company. Each student brings full funding from the state. The exchange students would not affect the class numbers. Eleventh grade is not full. Exchange students bring an added value to the school, and John thinks these students would be a good fit for MSA. Accepting these students is a trial.

Miscellaneous:

- All textbooks are ordered (approximately \$36,000)
- MSA curriculum meets state requirements.
- MSA's MCA results exceed benchmarks across the board.
- MSA composite ACT results are an average of 27.7.
- Parent surveys will be compiled next month.
