a. Student Rep Reports

- i. The Speech Showcase is this Friday, March 28, 2025, in White Bear Lake. Free and open to the public.
- ii. HOSA is attending the State Leadership Conference this weekend.
- iii. Student Spotlight: Joey Yapp for his Autism Awareness Month Project. Rocky Erickson for receiving the Outstanding Student of the Year award.
- iv. Sounds of Hope last Thursday raised half of their goal during the concert. Food drive happening this week supporting Open Cupboard.
- v. NHS Bingo Night on April 25th in the Great Hall to support charities of the winners' choice.



b. Board Report

- i. Finance training was completed during last week's workshop.
- ii. BOD members need a phone number that the public can use to contact you.
- iii. Members need to speak to the board chair and ED before communication to outside entities about board related items.

c. ED Report

- i. We are in the process of interviewing for an Elementary Principal position. Hoping to make a decision in early April.
- ii. Charter School Moratorium Bill was introduced at the Senate level, but did not get a hearing. There is no companion bill in the House, so it is unlikely to pass. This bill would restrict charter schools from adding grade levels.
- iii. The governor's proposed budget includes \$20,000,000 in budget cuts for charter schools. This is just a proposal, not passed. Please contact your relevant representatives to advocate for MSA.
- iv. Federal News: no news that would impact MSA at this time.
- v. Our 25-26 Budget: we are working on our preliminary budget for next year, to present to the board at the April meeting.
- vi. Enrollment is steady with few planning to leave MSA and few new students declining their spots. We are not concerned about hitting our enrollment targets. Q: Are we concerned about going over those targets? A: No.

d. Expansion Report

- i. JB Vang Construction Update: Previously planning to close March 25, 2025, but this has been delayed to April 15th due to bond changes. We are in the process of submitting our Land Disturbance permits. Costs have slightly increased due to the delay: \$11,250.
- ii. Bruce Sorensen Hilltop Securities Bonding Update: Taking on the debt to build the school caused MSA's S&P rating to decrease one step causing the delay. Q: Is 85% approval enough? A: Yes, we needed a simple majority. Q: It's expected for our bond rate to go down when acquiring new debt, that's standard, but is everything else going to plan? A: Yes, you get the best you could get on all other measures. Q: The report says we're going for \$69M in bonds, how much are we going to the city for? A: \$69M. Q: Enrollment projections for 2028-29 to the 2029-30 years show a 25 student loss from 11th to 12th grade, why? A: The total number remains the same, but the individual grade level enrollment may change.
- iii. What does this mean for the current project? New building will be the same size and look the same, the impact of higher rates and debt service means the budget to renovate the current building is halved and the contingency is also restricted. The project is operating on a tighter budget. Q: Is it possible to have an updated timeline at the workshop in April? A: Yes.

e. Finance Committee Report

- i. A summary of the January and February financials was provided.
- ii. Give to the Max funds were used to purchase 8 SmartBoards which are being delivered and installed. Teacher mini-grants are being approved



- and the funds are being utilized. We will likely have a fundraising Anniversary Picnic in the summer.

 Teachers have until May 1st, 2025 to get any last minute items for reimbursement on budget. iii.
